### CEO's Letter

Dear Friend,

New York State Community Action Agencies (CAA) are encountering challenges due to holdups in releasing funds and processing contracts by New York State. Suspending Articles 11-A and 11-B of the State Finance Law for prompt payment and contracting as directed on July 6th through Executive Order 202.48 has had a dire impact on the services provided by CAAs.

The network of forty-eight CAAs operate a number of vital and essential programs and services such as nutrition, childcare, housing, and employment to help and support families across New York State. CAAs are critical to the economies in their communities, providing jobs while serving and supporting vulnerable community members.

Late contracts and subsequent late payments has been a persistent problem for NY's not-for-profit organizations. In 2019, the State Comptroller issued a report that noted 50 percent of

contracts between not-for-profit organizations were executed after the contract start date, resulting in severe cash flow problems for organizations. In closing, the report noted:

*“Sustained efforts are needed to improve the cash flow to New York’s NFPs. Ensuring on-time contracts is critical to the success of the sector, and to maintaining the vital services NFPs provide to State residents”*

As the state responds to the COVID-19 pandemic, this statement could not be more true or critical to the mission of our agencies to protect low-income families. This continuing problem has created a situation where not-for-profit organizations across the state are struggling to keep their doors open at a time when their services are needed more than ever. Increased unemployment and reduced support services for individuals and families have put greater demand on the services and programs being provided by the Community Action network.

Without approved contracts and payments, CAAs across the state will be unable to provide critical services desperately needed during this pandemic and will be forced to lay-off employees and reduce services, adding to an already destabilized economy.

We urge the Governor to rescind the suspension of Articles 11-A and 11-B to support the non-profit network in serving vulnerable New Yorkers.

## Monthly Poverty Myth

***“All children have equal opportunities to succeed.” - False!***

Many people make the argument that even if a child is born into poverty, that child has the same opportunities in school as more wealthy children, and thus have at least some equal opportunity to succeed later in life. Unfortunately, the research demonstrates that the reality of the situation is quite the opposite.



22% of children who have lived in poverty do not graduate from high school, compared to 6% of children who have never lived in poverty, and shockingly 32% of children who spent more than half of their childhood in poverty do not graduate. These reduced rates of graduation for children in poverty cannot be explained by any one factor, however, there are some clear problems with the environment a child in poverty is raised in.

Whether the child is malnourished when he or she goes into school will determine the level at which that child will perform in school. Often schools in high poverty areas employ teachers with less experience and fewer advanced degrees, while the opposite is true in areas with less poverty.



## Census 2020


### 2020 Census Response Rate Map

The U.S. Census Bureau's [online map](#) shows the 2020 Census Response Rate Challenge — where state, local, and community leaders work together to promote a complete and accurate

count by increasing the self-response rate in their community. The map currently displays 2010 Census self-response rates as a reference point for states, counties, cities, and census tracts around the country. Users will be able to use the map to track their community's progress in responding to the 2020 Census.

As people respond to the 2020 Census online, by phone or by mail, the Census Bureau will update the map daily to reflect the percentage of households that self-respond online, by phone or by mail after being invited to do so. (The rate will be provided for the three modes combined and for online alone.)



### ***Hunger Solutions New York - Pandemic-EBT Outreach Toolkit***

Hunger Solution's new [webpage & outreach toolkit](#) provide resources to inform families about the new Pandemic Electronic Benefits Transfer (Pandemic-EBT/P-EBT)



program. The toolkit includes a flyer, letter template, social media posts, and infographics to help families learn about and use their P-EBT benefits. As trusted messengers, schools, community organizations, and other partners can use these resources to share information through their websites, robocalls/texts, social media, newsletters, and other communication channels.

Important highlights of Pandemic-EBT:

- **Each eligible child will receive \$420** in P-EBT food benefits.
- **P-EBT benefits can be used to buy food** at [SNAP-participating stores](#)
- **There is no application.** P-EBT benefits will be issued automatically between June and August. Families who receive SNAP, Public Assistance, or Medicaid will get benefits on their current EBT or Medicaid card. Others will receive a new EBT card in the mail.
- **Immigration status does not matter** for P-EBT. Using P-EBT does not affect a parent/guardian or child's immigration status. The public charge rule does not apply to P-EBT.
- **P-EBT is not SNAP, and does not replace other nutrition programs.** Families can still use other programs while using P-EBT. These include summer meals, SNAP, WIC, and "grab and go" or delivered meals from school.

## ***NY State of Health - Special Enrollment Period Extended through 8/15***

During these challenging times, NY State of Health, New York's official health plan Marketplace, remains committed to ensuring access to affordable, quality health insurance for all New Yorkers, so they can get the care they need.



NY State of Health is here to help New Yorkers who may have lost their health insurance coverage as a result of the COVID-19 pandemic to find and enroll in affordable, comprehensive coverage. Many New Yorkers will qualify for Medicaid, Child Health Plus or the Essential Plan due to loss of income/employment or reduced wages. Those qualifying for these programs can enroll year-round. Individuals who lose job-based health insurance should apply within 60 days of losing that coverage.

To help New Yorkers access health coverage during this time, NY State of Health has extended the Special Enrollment Period through August 15, 2020. ## ***Annie E. Casey Foundation - Kids Count Data Book: State Trends in Child Well-Being***

The 31st edition of the [Annie E. Casey Foundation's KIDS COUNT Data Book](#) describes how children across the United States were faring before the coronavirus pandemic began.

This year's publication continues to deliver the Foundation's latest available data on child well-being. It also identifies multi-year trends — comparing statistics from 2010 to 2018. As always, policymakers, researchers and advocates can continue using this information to help shape their work and build a stronger future for children, families and communities.

The Foundation derives a composite index of overall child well-being for each state by combining data across four domains: (1) Economic Well-Being, (2) Education, (3) Health and (4) Family and Community. These composite scores are then translated into a state ranking for child well-being.

### ***How to Build a Better Child Care System***
