In reality, the United States has the 2nd highest child poverty rate among developed nations at 23.1%. A report released by the United Nations Children's Fund (UNICEF) reveals alarming child poverty rates within affluent, or 'developed', nations. The United States ranks second highest among all measured countries, only behind Romania's 25.6 per cent.

Mark Your Calendar: Important 2020 Census Dates

- March 12-20: Initial invitations to respond online and by phone will be delivered by the U.S. Postal Service. Areas that are less likely to respond online will receive a paper questionnaire along with the invitation to respond online or over the phone.
- March 16-24: Reminder letters will be delivered.
- March 26-April 3: Reminder postcards will be delivered to households that have not responded.
- April 8-16: Reminder letters and paper questionnaires will be delivered to remaining households that have not been responded.
- April 20-27: Final reminder postcards will be delivered to households that have not yet responded before census takers follow up in person.
- May 13-July 31: If a household does not respond to any of the invitations, a census taker will follow up in person.

How Do I Respond to the 2020 Census and What Does it Ask Me?

The 2020 Census will count all people who live in the U.S. The census is a short questionnaire that asks basic information about your household and the people who live in it. Your personal responses are confidential and cannot be shared with other government agencies, including immigration enforcement, police, or housing authorities. The government uses the population count to divide up political representation and to determine where to spend resources.

In March 2020, the Census Bureau will mail information to households inviting them to respond to the census. There are three ways to participate: online, by phone, or by paper. [Click here](#) to read more.



U.S. Census Bureau - Putting 2020 Census Rumors to Rest

Every decade, technology plays a greater role in the way the census is conducted. But in 2020, the first time anyone who wants to respond to the census online has that option, the greatest change may come from the way all of us use technology.

For the first time during a decennial census, the majority of people in the United States are using digital and social media in their everyday lives. To prevent the spread of fake, false and inaccurate information, that can negatively influence 2020 Census participation and response, the Census Bureau has established the government's first ever Trust & Safety Team to protect the count.

The Community Action Partnership & NASCSP's Joint Statement on FY 2021 Budget Proposal

The Trump Administration released its [FY 2021 Budget Proposal](#), once again calling for the elimination of programs and services that are critical to raising families out of poverty, including the Community Services Block Grant (CSBG), the Weatherization Assistance Program (WAP), and the Low-Income Home Energy Assistance Program (LIHEAP).
