Monthly Poverty Myth

MYTH: No one in the United States goes hungry. - FALSE!

The [USDA](#) estimated that 11.1% of US households were food insecure in 2018. This means that approximately 14.3 million households had difficulty providing enough food for all their members due to a lack of resources. Rates of food insecurity were substantially higher than the national average for households with incomes near or below the [Federal poverty line](#).



56% of food-insecure households in the USDA survey reported that they had participated in one or more of the three largest Federal food and nutrition assistance programs in the previous month. One of these programs is known as [SNAP](#) or the Supplemental Nutrition Program. [Learn more about policies that help.](#)

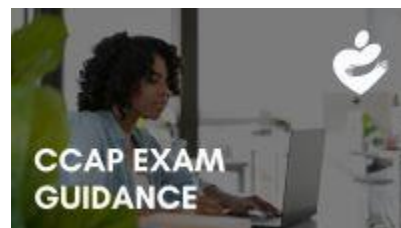

New COVID-19 Web Resources from CAPLAW

As winter approaches and we face new and increased COVID-19 challenges across the country, CAPLAW would like to remind the Community Action Network about two online resources that we are continually updating to assist the Network during this difficult time. These resources, initially released in spring 2020, contain in-depth information and analysis, and updates to them reflect evolving laws, regulations, guidance, and events related to the pandemic. They include:



- [Building Readiness: Planning, Prevention, Response, and Liability](#) - Contains guidance presented as a series of FAQs to anticipate and address many of the questions related to operating during the pandemic. The five sections addressed are: planning for onsite services, prevention and workplace safety protocols to minimize the spread of COVID-19, responding to known or suspected cases of COVID-19 in the workplace, liability issues around COVID-19 related claims, and other resources for additional guidance.
- [CARES Act Benefits for Nonprofit CAAs](#) - Provides details on certain benefits made available to non-profit CAAs through the federal Coronavirus Aid, Relief and the Economic Security Act (CARES Act), including the Paycheck Protection Program (PPP loans), Emergency Economic Injury Disaster Loans (EIDL), Main Street Lending Program, Employee Retention Credit, and payroll tax deferrals.

The Annie E. Casey Foundation - Kids, Families and COVID-19

This [KIDS COUNT policy report](#) examines how households with children are faring during the pandemic. Its findings are primarily based on surveys conducted by the U.S. Census Bureau.

Harvard University Center on the Developing Child - How Racism Can Affect Child Development

Years of scientific study have shown us that when children's stress response systems remain activated at high levels for long periods, it can have a significant wear-and-tear effect on their developing brains and other biological systems. This can have lifelong effects on learning, behavior, and both physical and mental health.



A growing body of evidence from both the biological and social sciences connects this concept of chronic wear and tear to racism. This research suggests that constant coping with systemic racism and everyday discrimination is a potent activator of the stress response. This may help us understand the early origins of racial disparities in chronic illness across the lifespan.

The evidence is overwhelming: Black, indigenous, and other people of color in the U.S. have, on average, more chronic health problems and shorter lifespans than whites at all income levels.

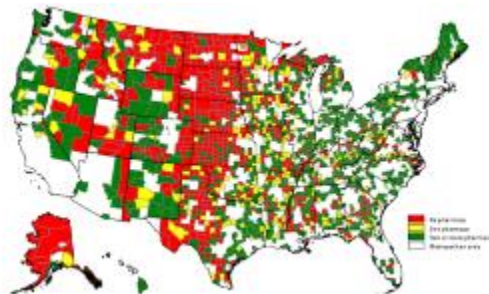

The Rural Blog - One-Third of Rural Counties Lack a Pharmacy Listed in Coronavirus Vaccination Plan

According to a new study, almost one-third of rural counties don't have a pharmacy partnered with a chain or network that's participating in the federal government's coronavirus vaccination program.

"The [study](#) from the Rural Policy Research Institute's Center for Rural Health Policy and Analysis found that 750 of the 1,962 nonmetropolitan counties in the study do not have a pharmacy that is listed in the federal Health and Human Services vaccine distribution partnerships," Tim Marema reports for

The Daily Yonder. "The combined population of those rural counties is about 5.6 million, according to the study, or about 13 percent of the rural population."



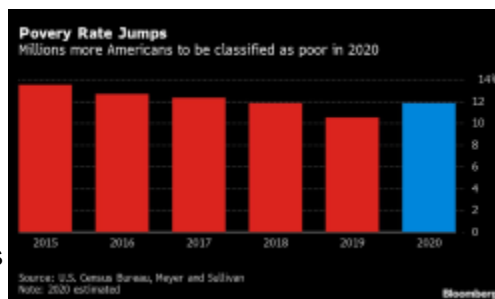
In November, the federal Department of Health and Human Service (HHS) said the vaccine would be distributed through chains such as Rite Aid, Walgreens, Kroger, Walmart, and independent pharmacy networks such as Good Neighbor Pharmacy, Marema reports. Such locations make up 60% of the pharmacies nationwide.

Bloomberg - U.S. Suffers Sharpest Rise in Poverty Rate in More Than 50 Years

The end of 2020 brought the sharpest rise in the U.S. poverty rate since the 1960s, according to a study released January 25, 2021.

Economists Bruce Meyer from the University of Chicago and James Sullivan of the University of Notre Dame found that the poverty rate increased by 2.4 percentage points during the latter half of 2020 as the U.S. continued to suffer the economic impacts from Covid-19.



That percentage-point rise is nearly double the largest annual increase in poverty since the 1960s. This means an additional 8 million people nationwide are now considered poor. Moreover, the poverty rate for Black Americans is estimated to have jumped by 5.4 percentage points, or by 2.4 million individuals.

Fostering Equity in Local Clean Energy Policy - February 25, 2021 - 1:30 PM EST

For local governments, prioritizing social equity in clean energy strategies begins with identifying groups historically underserved by energy efficiency and renewable energy investments, the disparate impacts of current policies, and who is poised to have a voice in future policy design and implementation. These concerns guide the American Council for an Energy-Efficient Economy's (ACEEE) work in supporting local communities working to advance social equity through clean energy initiatives. Historically, many marginalized groups have been underserved, overlooked, and underrepresented in local clean energy planning and policymaking. These groups can vary from place to place but often include people of color, low-income residents, older adults, indigenous peoples, immigrants, people with disabilities, and people experiencing homelessness. Join this webinar to learn about what can be done to address the barriers to clean energy facing marginalized communities, including an exploration of five dimensions that can be used to evaluate how cities and their local utilities are creating, promoting, and supporting socially equitable clean energy strategies.
