

## NY State of Health - Important Changes to New York Medicaid, Child Health Plus and the Essential Plan

Do you or a family member currently have health insurance through New York State Medicaid, Child Health Plus or the Essential Plan? Starting in Spring 2023, New York State will resume eligibility reviews and renewals for people enrolled in these programs. This means you may need to take action to renew your health insurance or the insurance of your family members. Here are some things you can do now to get ready.

#### Sign up for text alerts.

Sign up to receive SMS/MMS Text alerts from NY State of Health so you don't miss important health insurance updates, including when it's time to renew your coverage. - To subscribe, text START to 1-866-988-0327.

#### Make sure you address is up to date.

Make sure NY State of Health has your current mailing address, phone number and email address so they can contact you about your health insurance. To update your information:

- Call NY State of Health at 1-855-355-577
- Log into your account at <u>nystateofhealth.ny.gov</u>, or
- Contact an <u>enrollment assistor</u>

If you enrolled in Medicaid through <u>your county's Medicaid</u> <u>office or through New York City's Human Resources</u> <u>Administration</u>, contact that office to update your address and contact information.

#### Take action

When it is time to renew your health insurance, you will receive a letter from NY State of Health or a renewal packet if you enrolled through your county's Local Department of Social Services or the New York City Human Resource's Administration. This letter/packet will let you know what you need to do to renew your coverage and how much time you have to respond. Follow the instructions right away.

# What if you don't qualify for Medicaid, Child Health Plus or the Essential Plan?

If you or a family member no longer qualify for Medicaid, Child Health Plus or the Essential Plan, you may be eligible to enroll in a Qualified Health Plan (QHP) through NY State of Health. NY State of Health offers a broad choice of QHPs with comprehensive benefits. More people than ever are qualifying for financial assistance to pay for their premiums. ## NYS MyBenefits Tool Connects Residents to Benefit Programs

NYS has released an online tool for State residents. This resource allows individuals to check eligibility for multiple human services benefit programs and apply online for the Supplemental Nutrition Assistance Program (SNAP), the Home Energy Assistance Program (HEAP), and Temporary Assistance.

## ACF Announces New Name for Federal Child Support Office to Reflect Family-Centered Approach

The Administration for Children and Families (ACF) at the U.S. Department of Health and Human Services has announced that it has renamed the Office of Child Support Enforcement to the Office of Child Support Services (OCSS). This change reflects the program's commitment to serving the whole family and promoting family self-sufficiency. The program will continue offering many services, including enforcement remedies. It will continue to partner with child support agencies and others to encourage parental responsibility, so children receive reliable support from both parents.

## Helpful Tips to Avoid Affordable Connectivity Program Scams

The <u>Affordable Connectivity Program (ACP)</u> is a public program that helps eligible households save on their monthly Home Internet. Be cautious, make sure you're signing up for the REAL ACP!

Tips to steer clear of ACP scammers:

- 1. Never pay to sign up for ACP benefits.
- 2. Never give out your financial information.

- 3. Never apply through a company that says you cannot change to a lower-priced service.
- 4. Only apply for the ACP benefit through verifies and trusted channels, such as the FCC's official website.

## Housing for Trans People, by Trans People

Nationwide, trans people experience disproportionate rates of housing instability. With a poverty rate three times that of the general population, Black trans people experience this challenge most acutely. <u>Urban Institute</u> research explores how one trans-led organization in Atlanta reduces homelessness and supports housing stability for trans women.

Learn more about one resident's experience with the Trans Housing Coalition. This organization places Black and Latina transgender women in transitional and permanent housing and partners with other services to help trans women secure stable futures.

## Making Workforce Development Systems More Racially Equitable and Inclusive

The <u>Annie E. Casey Foundation</u> launched the Generation Work initiative in 2016 to connect more of America's young adults—especially those of color from low-income families with the knowledge and experience necessary to succeed in today's job market. The initiative seeks to address structural inequities in local workforce development systems and asks the partner organizations to examine their practices to change them to serve young people better and advance racial equity and inclusion (REI). This issue focus highlights a few promising strategies that the Generation Work partnerships have pursued to foster awareness of REI among the organizations and their staff and to translate this awareness into changes in organizational practices.

## United for ALICE 2023 Annual Report -ALICE in the Crosscurrents: COVID and Financial Hardship in the United States

This ALICE Report provides the first look at the extent of financial hardship in the U.S. using ALICE metrics since the COVID-19 pandemic began. The pandemic has disrupted longstanding patterns in how and where people live, work, study, save, and spend their time. And the story of ALICE and the pandemic is still unfolding as this report is being written, amid an ongoing health crisis and an economic and public policy landscape that continues to shift. In a time of change, United For ALICE remains committed to providing the most up-to-date local data possible on financial hardship across the U.S.

## Household Pulse Survey Shows 31.1% Reported Symptoms Three Months or Longer After They Had COVID-19

Hispanic and Black respondents were more likely than other racial or ethnic groups to report COVID-19 symptoms lasting three months or longer, according to the U.S. Census Bureau's Household Pulse Survey (HPS).

The HPS, an experimental online survey representative of the U.S. adult population at the state and national level, began asking about long COVID symptoms in June of 2022, more than two years after the pandemic hit the United States. It found that 31.1% of respondents ages 18 and over reported long-lasting symptoms.
