

Highlights from our Agencies

Community Action Partnership for Dutchess County

Rep. Sean Patrick Maloney (NY-18) announced [Community Action Partnership for Dutchess County](#) was awarded a \$88,479 Senior Corps grant through the Americorp's Corporation for National and Community Service (CNCS), the federal agency for volunteering and service.

This grant will support over 300 Senior Corps volunteers in the RSVP program and expand Senior Corps' presence in the Hudson Valley. Community Action Partnership for Dutchess County is one of only 10 awardees from New York State.



Westchester Community Opportunity Program

[Westchester Community Opportunity Program, Inc.](#) ([WestCOP](#)) appeared on NBC Nightly News with Lester Holt. Members of the National Guard arrived in New Rochelle, New York, to help distribute food at New Rochelle Community Action Program, which is one of several WestCOP locations in Westchester County. The food will go to families and students from the three New Rochelle public schools that are closed in the containment area, namely, the roughly 2,800 students who qualify for free and reduced price lunch.

2020 Census Operational Adjustments Due to COVID-19

MARCH 28, 2020 — Based on continuing assessments of guidance from federal, state and local health authorities, the U.S. Census Bureau is [suspending 2020 Census field operations](#) for two additional weeks to April 15, 2020. The Census Bureau is taking this step to help protect the health and safety of the American public, Census Bureau employees, and everyone who will go through the hiring process for temporary census taker positions.



2020 Census Response Rate Map Preview Now Available

The U.S. Census Bureau launched [a new online map](#) this week as part of its 2020 Census Response Rate Challenge — where state, local, and community leaders work together to promote a complete and accurate count by increasing the self-response rate in their community. The preview map currently displays 2010 Census self-response rates as a reference point for states, counties, cities, and census tracts around the country. Users will be able to use the map to track their community's progress in responding to the 2020 Census.

As people begin responding to the 2020 Census online, by phone or by mail in mid-March, the Census Bureau will update the map daily to reflect the percentage of households that self-respond online, by phone or by mail after being invited to do so. (The rate will be provided for the three modes combined and for online alone.)

National Community Action Foundation (NCAF) Conference Postponed

Due to the accelerating outbreak of the coronavirus, the [National Community Action Foundation \(NCAF\)](#) is postponing its March conference in Washington, DC. New York State of Health - Special Enrollment Period Through April 15th for Uninsured Individuals

NY State of Health, together with the New York State Department of Financial Services (DFS), announced that New Yorkers will make a [Special Enrollment Period](#) available to New Yorkers during which eligible individuals will be able to enroll in insurance coverage through NY State of Health, New York's official health plan Marketplace, and directly through insurers. NY State of Health, DFS, and New York State health insurers are taking this action due to the exceptional nature of the public health emergency posed by the COVID-19 so that individuals do not avoid seeking testing or medical care for fear of cost. The open enrollment period for coverage in 2020 had previously ended on February 7, 2020.

Individuals who enroll in Qualified Health Plans through NY State of Health or directly through insurers between March 16 and April 15, 2020 will have coverage effective starting April 1,

2020. Individuals who are eligible for other NY State of Health programs – Medicaid, Essential Plan and Child Health Plus – can enroll year-round. As always, consumers can apply for coverage through NY State of Health on-line at nystateofhealth.ny.gov, by phone at 855-355-5777, and working with [enrollment assistors](#).



American Way of School Funding is 'Uniquely Bad' for Inequality

Rising inequality is now at the heart of U.S. public debate, looming over just about every policy discussion from trade to interest rates and likely to take center stage in this year's presidential election. America's classrooms are one place where the trend could be halted.



U.S. schools get most of their money from state and local authorities. The latter typically rely on property taxes to raise revenue and can do it more easily in wealthy neighborhoods. It's a "uniquely American" system, says Elaine Weiss, a researcher at the Economic Policy Institute. And its distributional consequences are "uniquely bad," she says. "Some kids, just by dint of where they are born, will have much less funding."

Empire Justice Center - Shouldering the Strain: How Counties Cope with Inadequate Child Care Funding

At an annual cost of \$15,394, quality child care is unaffordable for 90% of New York families. New York State ranks 6th out of all 50 states for the most expensive infant care. In fact, a minimum wage worker would have to work for 35 weeks just to pay for one infant's child care! Yet subsidized child care is underfunded and increasingly unavailable.



Shouldering the Strain: How Counties Cope with Inadequate Child Care* breaks down the top methods that counties across New York State employ to deal with this chronic and worsening underfunding. Based on data collected by Empire Justice from July to August of this year, this report includes up-to-date information on the methods counties use to try and stretch child care funds, from lowering eligibility levels or closing intake to denying subsidies to parents and caretakers with disabilities. Internal Revenue Service (IRS) - Form W-4 & Tax Withholding Estimator

Tax Withholding Estimator: The IRS encourages everyone to use the [Tax Withholding Estimator](#) to perform a “paycheck checkup.” This will help you make sure you have the right amount of tax withheld from your paycheck. There are several reasons to check your withholding:

- Checking your withholding can help protect against having too little tax withheld and facing an unexpected tax bill or penalty at tax time next year.
- At the same time, you may prefer to have less tax withheld up front, so you receive more in your paychecks and get a smaller refund at tax time.

Form W-4: The IRS has released the final version of the 2020 [Form W-4](#). The new form must be used by all new employees hired on or after January 1, 2020 and any employees who wish to adjust their federal withholding on or after January 1, 2020.
